SbCNet has now provided the parliament with its project plan that would pave the way for it to restart the installation, configuration, testing and commissioning of this project that will help the federal parliament automate all its operation.

"The project plan submitted will be accepted in principle subject to changes here and there," said Sylvester Ogbolu, project manager representing the consulting firm, YMG Technology and Trading Services Plc.

Sophia has disclosed that her company will start work on the project within the coming two weeks, committing to complete it in six months. "We will complete it within the shortest time possible," she said in her exclusive interview with Fortune.
